



About Mobile Crisis Response



- » Mental health and/or substance use
- » Delivered "in the field"
- » Treatment services by licensed and appropriately certified clinicians
- » Triage/screening and assessment
- » De-escalation/resolution peer support
- » Coordination and referral with medical and behavioral health services
- » Crisis planning and follow-up

Action Plan Requirements

- » Must be submitted by February 14, 2023
- » Expected Activities:
 - » Stakeholder Involvement and Coordination
 - » Community Assessment
 - » Action Plan Development
- » May include request for funds for infrastructure

Community Engagement & Coordination

- » County representatives
- » Tribal representatives
- » Behavioral health providers
- » First responders



- » Individuals and family members who have lived experience
- » Other community members

Assessing Resources, Needs, & Gaps

- » Learn about effective mobile crisis and best practices.
- » Assess need and resources for a mobile crisis service in your community.
- » Consider who, what, when, where, why, and how for possible mobile crisis response.
- » Consider how mobile crisis response will fit with other crisis (and noncrisis) services.
- » Consider how it will link with other system transformations currently underway.
- » Identify best practices that are relevant and applicable in your community.

Write it down—use a mix of quantitative and qualitative information—and get feedback.


The Assessment should inform the Action Plan.

What should be in the Action Plan?


Introduction and summary of Community Assessment Community vision and goals Objectives, including milestone(s), timeline, responsible party, and evaluation If applying for infrastructure funds, Plan must include an implementation grant application and deliverable schedule for these funds.


